permission needed for the outside paint. There are no update on possible plans to redevelop Bexhill Town Hall. Local taxis firms are refusing short journeys.

### **Public Questions**

A resident asked the council to reconsider it use of pesticides on the playing fields as this potentially harmful to animals and their food chain. The council will investigate this.

The opportunity to plant tree for the Queen's Platinum Jubilee was mentioned and that monies could be raised from public donations.
