8. **Iden Playing Fields and Pavilion**

Review of meeting with pavilion association regarding risk assessment and pavilion future.

Noting that the parish council has the prime responsibility to ensure the safety of its assets and as landlords, **to agree that the risk assessment for the Pavilion be brought forward to April 2017 under the terms of the lease granted to the tenants before the building is brought back into use.**

To agree that a letter is sent to the Pavilion Committee stressing the importance the Council places on the building's safety and asking them to confirm in writing all the outstanding matters raised by the assessor last October have been dealt with and to advise formally in writing what steps have been taken to safe guard the building whilst it is closed.

Noting that the playing field fences are now in need of repair, particularly behind the Pavilion, to consider how these may be restored.

To agree to reconsider the fee set for Iden Cricket Club for 2017-2018 for hiring Iden Playing Field. Currently set at £200 for the season for Saturdays.

9. To ascertain what is happening regarding the enhancements to ensure the 30 mph speed limit through the village.
