To agree to Beckley Football Club (Juniors under 16 team) hiring Iden Playing Field on Saturday mornings for the 2015 2016 Season for an annual fee of £300 to be charged 50 % in October and £50 % in January subject to prior receipt of a copy of their Public Liability Insurance and Child Protection Policy. As the club has no current available match ground for the under 16's, Beckley F C has been allowed to hold a match on Saturday 3rd October morning at Iden Playing Field.
- 7. To agree to Acquiring a New Lock and Keys for Iden Playing Field Gate.
 Estimated priced £100. Each user body to receive 2 keys and charged £10
 deposit (against cost of replacement). A record of key holders to be maintained. Keys will be of a type that can not be copied
- 8. Following a request from the Iden Cricket Club, to agree to refund Iden Cricket Club £50 against the 2015 fee and to agree to reduce the annual hire fee to £150 for the future.
- 9. To agree the request for Memorial Stone for Clive Alan Stone: polished black granite with appropriate inscription and suitable anchorage. £100 fee received.
- 10. SALC AGM agenda item 9. To consider the recommendation by the Board that late payment of subscriptions and invoices by members will incur a late payment fee of 4% over base rate or £10 whichever is the higher.
